#### **Pastoral Care for the Sick**

We will be asking Deans to coordinate with the pastors and priests of their deaneries to establish a plan for continuing the Pastoral Care of the Sick. Bishop Campbell, Bishop Fisher and Fr. Anthony Lickteig will be coordinating with the Deans and providing additional guidance on this and will be available to answer questions. The plan will include having designated priests that volunteer to be limited to anointing of the sick with the coronavirus and be required to take extra precautions, such as stay in self-isolation when they are not anointing. All other

priests would still be available for anointing of the sick and those suffering from other serious illness aside from the coronavirus.

As a reminder for pastoral care of the sick, please make sure to follow all current protocols recommended by health professionals. In the event that you are asked to anoint someone with the coronavirus, the Code of Canon Law permits the use of an instrument (CIC 1000 §2), for example, a cotton swab. In such a case, the instrument used should not come in contact again with the oil stock and should be disposed of immediately in a reverent manner. In case of necessity, a single anointing on the forehead or on any other part of the body with the entire sacramental form ("Through this holy anointing... May the Lord who frees you from sin...") suffices (CIC 1000 §1; PCS, 23). For further clarification, please contact Rev. # Care for Elderly Priests and/or Priests with Underlying Conditions

Elderly priests and/or priests with underlying health conditions are more susceptible than others to complications from the coronavirus. If you fall in this category, please take extra precautions. This may include exercising some level of self-isolation in one's room and/or limiting time around others.

### **Local Jurisdiction Updates**

State of Maryland Governor Larry Hogan today announced a change in their legal mandate, limiting gatherings to 10 persons. The District of Columbia's legal mandate remains at up to 50, with the exception being gatherings with people 60 years or older to be limited to 10 persons.

## **Human Resources and Staffing**

On Friday, March 13, 2020 the Moderator of the Curia provided materials and guidelines to pastors on ADW Emergency Preparedness (Emergency Preparedness Measures linked **here**) as we manage the COVID 19 pandemic in the coming weeks. The guidelines provide direction on how school and parish employees should be compensated. As a reminder, <u>employees may not be terminated</u>, <u>have a reduction of hours</u>, <u>or be laid off without guidance and written approval from HR</u>. We continue to monitor all pending Federal legislation that might offer support or resources for our locations and/or employees and will provide guidance as it becomes available.

#### **Financial Considerations**

We have a multi-disciplinary team assessing and developing guidance on financial considerations that may be needed as we move forward in the weeks ahead. The state of Maryland 2020 Legislative Session has concluded, and the BOOST Program has been approved for 2020-2021. The Program will provide \$7.5 million for scholarships next year.
