Good Friday Solemn Intercession and Mass in Time of a Pandemic

Recently, the Congregation for Divine Worship published a version of the Good Friday Solemn Intercession that may be used. The previously published intercession from the USCCB may also be used. Linked **here** are both versions of the Solemn Intercession.

The Congregation for Divine Worship also has issued a new votive Mass text for "Mass in time of Pandemic:"
