### **Day of Reflection - XIII National Black Catholic Congress**

The XIII National Black Catholic Congress will be held July 20-23, 2023, at the Gaylord National Resort and Convention Center at National Harbor, Maryland. In preparation for the Congress, The Roman Catholic Archdiocese of Washington will conduct a Day of Reflection on Saturday, November 5, 2022, to discern and dialogue with the faithful to identify their needs, interests, and concerns. This Day of Reflection will take place at Saint Joseph Catholic Church in Largo, MD, on Saturday, November 5, 2022 from 12:30 p.m. – 6:00 p.m. Bishop Roy Campbell will celebrate Mass at 5 p.m.

The Day of Reflection will result in a report that will be submitted to the National Black Catholic Congress to assist with the Congress proceedings. The Day of Reflection is open for participation of the faithful in the Archdiocese.

## **Reminder about Montgomery County Nonprofit Security Grants**

Montgomery County has announced that it is providing \$800,000 in Nonprofit Security Grants for organizations in the County experiencing hate crimes or are at risk of becoming targets of hate crimes. Facilities (parishes/schools) can qualify for up to \$20,000. Funds may be used to pay for a security assessment or plan and associated expenses, to purchase security cameras for the facility, to retain current security personnel or augment current security personnel, to conduct security training, and/or to develop and execute a security drill.

Application forms may be found [here](#). The application period will close October 26, 2022. Parishes/schools will be notified of award decisions in early December. When filling out applications, parishes/schools should keep be aware that information provided in the application is subject to public disclosure. If awarded funds, parishes/schools should send the final grant agreement to [Legaladmin@adw.org](mailto:Legaladmin@adw.org) for final review before signing.
