What is a Circle of Grace?

The Catholic Church teaches that God has created each of us as unique and special. Genesis 1:27 tells us that we are created "male and female in God's image" and that God saw this as "very good." In that goodness, we are meant to respect ourselves and everyone else as persons created and loved by God.

Adults assist children to recognize God's love by helping them to understand that each of us lives and moves in a *Circle of Grace*. You can imagine your own *Circle of Grace* by putting your arms above your head then circle down in front of your body including side to side. This circle, front to back, holds who you are in your body and through your senses. It holds your very essence in mind, heart, soul, and sexuality.

Why is it important to help our children understand the Circle of Grace?

God intends our relationships in life to be experiences of divine love. Respectful, nurturing, loving relationships increase our understanding of our own value and help us to love others. It is never too early to help children understand how very special they are and how relationships in life are called to be sacred. Understanding this can help them to protect the special person they are and to be respectful of others.

Adults, as they strive to provide a safe and protective environment, hold the responsibility to help children understand and respect their own dignity and that of others. A truly safe and protective environment is one where children recognize when they are safe or unsafe and know how to bring their concerns, fears, and uncertainties to the trusted adults in their lives.

How is the Circle of Grace Curriculum different from other safety programs?

According to research, one in four girls and one in seven boys will be sexually abused by age eighteen.¹ Many protection programs focus on "stranger danger,", however, up to ninety percent of the time the perpetrator is a relative, family friend or other person known to the child/young person. *Circle of Grace* goes beyond just protection by helping children understand the sacredness of who they are and how to seek help through their relationships with trusted adults.

Goal of the Circle of Grace Curriculum - Grades K-12

The goal of the *Circle of Grace* curriculum is to educate and empower children and young people to actively participate in a safe environment for themselves and others.

Objectives of the Circle of Grace Curriculum - Grades X-12

- Children/Young People will understand they are created by God and live in the love of the Father, Son, and Holy Spirit.
- Children/Young People will be able to describe the *Circle of Grace* which God gives each of us.
- Children/Young People will be able to identify, discern and maintain appropriate physical, emotional, spiritual, and sexual boundaries.
- Children/Young People will be able to identify all types of boundary violations.

Grade 4 Leader Guídelínes

- A **Leader** is defined as clergy (priest or deacon) school administrator, director of religious education/formation, teacher, or catechist who has been trained to teach the *Circle of Grace* Curriculum.
- Every leader should read the Philosophy, Goals and Key Concepts to better understand and prepare to teach the *Circle of Grace*. The Key Concepts review the essence of the curriculum, that God is always present in our *Circle of Grace* because He desires an intimate relationship with His children.
- The time frame may vary depending on size of class, age of children, amount of discussion, etc.
- Vocabularies with definitions are intended for the leader. The explanation of vocabulary should be integrated within the context of the lessons to assist the children in their understanding of the *Circle of Grace* Curriculum. The depth of the children's understanding will depend upon their age and developmental stage. A master vocabulary list is in the administration/director section. The pertinent vocabulary is listed in each lesson.
- Leader's instructions for each lesson are italicized. Non-italicized text needs to be presented by the leader to the students.
- If possible, it is always "best practice" to have two adults in the room during the lesson due to the sensitive nature of the material.
- Ongoing reinforcement of the concepts is encouraged throughout the year. Hopefully, the language of *Circle of Grace* will become a part of a positive culture of respect, care, and faith that will help protect our children and help them to know what to do when they feel unsafe.
- Your School Administrator or Religious Education Director will be sending out a letter to all parents regarding *Circle of Grace*. Lesson specific parent information should be handed out as directed. The Parent information is included in the curriculum. Every parish/school is encouraged to provide parent education opportunities both to inform parents about the *Circle of Grace* curriculum and to foster greater communication in families.
- Evaluations for each grade are to be completed and returned to the School Administrator or the Director of Religious Education/Formation. The evaluations will be used to complete the Summary Evaluation that is used for ongoing improvement of the curriculum and for the audit records.

Summary of the Key Concepts of "Circle of Grace"



God gives each of us a *Circle of Grace* where He is always Present:

Raise your hands above your head, then bring your outstretched arms slowly down. Extend your arms in front of you and then behind you embrace all of the space around you

slowly reach down to your feet.

Know that God is in this space with you. This is your Circle of Grace; you are in it.

God is Present because He desires a relationship with us.

- God is with us when we are happy and sad. God does not cause bad things to happen to us. He loves us very much.
- God desires to help us when we are hurt, scared or confused (unsafe).
- Having faith may not take away all of life's struggles. It is because of these struggles, God promised to always be present; providing guidance and comfort in our time of need.

God helps us know what belongs in our Circle of Grace

- Our feelings help us know about ourselves and the world around us.
- God helps us know what belongs in our *Circle of Grace* by experiencing peace, love or contentment when something or someone good comes into our *Circle of Grace*.

God helps us know what does not belong in our Circle of Grace

- God desires to help us when we are hurt, scared or confused (unsafe).
- The Holy Spirit prompts (alerts) us that something does not belong in our *Circle of Grace* by giving us "a funny or uncomfortable feeling" that something is not safe. This feeling is there because God wants us to be safe.

God helps us know when to ask for help from someone we trust.

 God gives us several trusted adults, in addition to our parents, to talk to about our worries, concerns or "funny/ uncomfortable feelings" so they can help us be safe. If a parent or trusted adult is not available or unable to help us, God wants us to go to another trusted adult until we get the help needed to be safe.

Social Media and our Circle of Grace: What is the Big Deal Anyway?

Sometimes children reveal personal information or details about incidents that, in order to respect confidentiality, need to be handled outside of the classroom. If this happens, tell the child, "Thank you for sharing that, ______. That sounds really important. I will talk to you about that later" (at the end of class, at the break, as soon as humanly possible, etc.) When this happens, be sure you talk to the child at your first opportunity and alert the administration. Remember that you are the responsible reporter in cases of suspected abuse.

This lesson complements the following Catholic teachings:

- Jesus' life as a model for our own
- God calls us to be responsible for our actions
- Jesus modeled how we should serve others
- God teaches us to lead a healthy life and make good choices
- Human life is sacred and must be respected
- Responsible relationships are based on love, honesty, and respect
- We are called to respect the human body as sacred life
- Our conscience helps us to know what is right and to do what we believe is right
- God calls us to be responsible for our own actions

Lesson Goal

Children will come to understand the concept of a *Circle of Grace* in relation to using social media, in healthy and unhealthy ways.

Lesson Objectives

Children will be able to:

- 1. Understand the difference between a safe secret and an unsafe secret when using social media.
- 2. Recognize and define different types of social media and how they influence our Circle of Grace in positive and negative ways.
- 3. List positive uses of social media.
- 4. Review and describe their personal *Circle of Grace*.
- 5. Identify the different social media platforms and apps.
- 6. Identify behaviors that would be appropriate in relation to a child's *Circle of Grace* when using social media.
- 7. Identify boundary violations when using social media.
- 8. Formulate an action plan for safe use/safe exit when using social media.
- 9. Understand that trusted adults help us stay safe in our Circle of Grace and help us respect others in their Circle of Grace.

Vocabulary

Review and Reinforced with Students

- 1. **Boundary**: The borders or limits we need to keep ourselves safe within our *Circle of Grace*.
- 2. <u>Circle of Grace</u>: The love and goodness of God which always surrounds me and all others.
- 3. <u>Safe Secret</u>: A secret is safe when it does not hurt oneself or others.
- 4. <u>Unsafe Secret</u>: A secret is unsafe when one thinks that someone, including oneself, might be hurt or get in trouble if one does not tell. A secret is always unsafe if someone states you are not to tell your parents or trusted adults.
- 5. <u>**Trust**</u>: Being able to count on someone to help one to stay safe within one's *Circle of Grace*.
- 6. <u>**Trusted Adult**</u>: A grown-up who helps one to stay safe in their *Circle of Grace* and to respect others within their *Circle of Grace*.

The below general social networking definitions are for the leaders to know and use at their discretion. Specific business/companies are not named due to copyright statutes. You can use the specific names when teaching the lesson. A child needs to be 13 years old for most social networking sites. This age limit has been dictated by U.S. law through the Children's Online Privacy Protection Act (COPPA). So, the students are probably aware of them but should not be using them.

- 7. <u>App:</u> an application, especially as downloaded by a user to a mobile device.
- 8. <u>**Blog**</u>: An online journal. Personal stories or thoughts can be posted as in a personal journal. This is a public journal that anyone can access.
- 9. <u>Chat Room</u>: The name given to a place or page on a website or online service where people can chat with each other by typing messages which are displayed almost instantly on the screens of others who are in the chat room.
- 10. **Direct Message:** This is a private form of communication, seen only between the sender and the recipient.
- 11. <u>Instant Messaging (IM)</u>: Technology similar to that of chat rooms which notifies a user when a person is online allowing them to converse by exchanging text messages.
- 12. <u>Location Application</u>: An application used in phones to find a location of a popular spot (restaurant, park etc.). People use the application to check in and it broadcast the location to all of their friends.
- 13. <u>Micro Blogging</u>: This service allows users to give updates about what they are doing using around 20 to 300 words.
- 14. Photo Sharing App: Captures, edits & shares photos, videos & messages with friends & family.
- 15. <u>Social Networking Service and Websites</u>: These services and websites are used to communicate with (a person) or search for information about (a person)
- 16. <u>Video Sharing Service</u>: This service allows users to watch videos posted by others and to upload videos of their own.
- 17. <u>Mobile Video App</u>: Allows videos and pictures to be sent both which will disappear after about 10 seconds of a person viewing them. They can be viewed after the 10 seconds if a did a screen shot was done.

Below Vocabulary is for students, per your discretion. Feel free to add additional age-appropriate terminology as it changes often. You may consider having them do "thumbs up" or "thumps down" if they know the word. It is provided not to have the students memorize but to aid you in teaching the content.

- 1. <u>**Cyber Bullying**</u>: Use of the internet, cell phone or other electronic devices to send or post texts or images intended to hurt or embarrass another person.
- 2. <u>E-mail</u>: Electronic mail. Sending/ receiving a type written message from one device to another.
- 3. <u>Flaming</u>: Sending a deliberately confrontational message to others on the internet/ social media.
- 4. **Inappropriate Material**: Pictures or words on the internet that make one feel uncomfortable scared, or that intentionally degrade a human person.
- 5. **Inappropriate Media**: Images, words that are spoken or written, that make one feel uncomfortable/scared, is disrespectful to people a parent/trusted adult would not give approval.
- 6. <u>Netiquette</u>: Courteous, honest, and polite behavior practiced on the internet/ social media.
- 7. <u>**Personal Contact Information**</u>: Information that allows an individual to be contacted or located in the physical world, i.e., a telephone number or an address.
- 8. **Phishing**: An identity theft scam in which criminals send out spam that imitates the look and language of legitimate correspondence from e-commerce sites. The messages generally link to websites that are similarly faked to look like the sites of the respected companies. On the sites, users are directed to enter their personal information for authentication or confirmation purposes. The information, when submitted, goes to the thieves not to the "spoofed" company.
- 9. <u>**Pop Up**</u>: A term for unsolicited advertising that appears as its own browser window.
- 10. <u>**Predator**</u>: Someone who uses the internet or other means to obtain personal information about others with the intent to do harm.
- 11. <u>Smart Phone</u>: A mobile phone that offers advanced features like the internet, camera and applications such as games, and special interest information.
- 12. <u>Social Media</u>: refers to websites, apps or other online means that allow people to interact with others or create and share content. It gives users quick electronic communication of content, such as personal information, documents, videos, and photos.
- 13. <u>**Texting</u>**: Sending a short text (typed) message and /or photo between cell phones or other handheld devices.</u>
- 14. <u>Webcam</u>: A front facing video camera that attaches to a computer or is built into the laptop.
- 15. <u>**Catfishing**</u>: the process of luring someone into a relationship by means of a fictional online persona.

Materials Needed:

- 1. Summary of the Key Concepts of "Circle of Grace" for each youth (front of the lesson).
- 2. Chart paper or marking board for listing uses of the social media.

- Activity 1- Two Social Media Smart Activity Sheets for each student (end of lesson) (One to use in class and one to send home) One Children's Rules and Guidelines for Social Media for each student.
 - (will be sent home with the parent letter) (end of lesson)
- 4. Activity 2- Paper, pens, and samples of newspaper clippings, advertising, websites etc.
- 5. Parent Letter with attached activity sheet (end of lesson)

Opening Prayer

Leader calls class to prayer by asking children to quiet down and join in the Sign of the Cross. Then say together,

Holy Spirit, show us the way. Be with us in all we think, do, and say. Amen

It is important to begin the lesson by explaining that God does not want or cause bad things to happen. There will be young people who have already experienced unsafe or hurtful situations. It is important to reinforce that it is not their fault, and it is never too late to tell a trusted adult. We want our young people to understand that God is with them and for them even when they are hurting or sad.

Part 1 Getting Started

Distribute and review the Summary of the Circle of Grace Concepts in the front of the lesson. Spend some time helping the youth to relate each section of the summary to their everyday life. It is helpful to have the Circle of Grace Logo available. The points below will aid in the discussion.

- 1. We are all made in the image and likeness of God and therefore we are sacred and holy, deserving of great respect.
- 2. Jesus told us that he would always love us and His Spirit would always be with us. If we are always in His presence, we are always in a special, holy place. We call that place our *Circle of Grace*.
- 3. If we remember that we are in a *Circle of Grace*, that God is there with us and we are surrounded by His love, we will remember to behave with special respect for ourselves and for others. God is with us because he desires a close relationship with each o

4. Leader to reinforce the children's understanding of the difference between a safe secret and an unsafe secret (see Vocabulary). It is important to point out that safe secrets many times are told eventually like surprises (birthday or Christmas gifts). A secret is not safe if someone tells you never to tell it especially to a trusted adult.

Discussion

(Review with students the below definitions)

<u>Social Media</u>

Social media refers to websites, apps or other online means that allow people to interact with others or create and share content. It gives users quick electronic communication of content, such as personal information, documents, videos, and photos.

<u>Inappropriate Social Media</u>: Images, words that are spoken or written, that make one feel uncomfortable or scared, disrespectful to people or would be something a parent/trusted adult would not give approval.

During the discussion, have children make a list of positive and negative uses of social media. Write responses on a chart paper or marking board. Think about the analogy of how the use of a hammer can be used to build things (positive) or destory things (negative). This may be a good analogy for the children.

Discussion – Children's Rules and Guidelines for Social Media

Present and discuss the following (copy of these rules and guidelines are at the end of the lesson for the children to take home to their parents):

BE SMART: (Never forget your Social Media safety rules with any eletronic device or in any location!!)

- Never give out or post personal information such as your address, telephone number, parents' names and phone numbers, grade level, or where you go to school.
- Never assume someone is who they say they are. They are not "friends" if you have never met them in person.
- Treat everyone that you encounter online as a stranger using the same rules for dealing with strangers online as you would for strangers you see on the street.
- Never agree to meet someone in person that introduced themselves on the internet without a parent's or trusted adult's approval.
- Never send a picture or anything else to someone who requests it. Tell your parents or trusted adults about the request.

- A package or piece of mail that is delivered to you from someone you met on line must be opened by your parents.
- Tell a trusted adult if someone sends you a picture or message that makes you uncomfortable or you know your parents would not approve.
- If you come across information on the internet that makes you feel uncomfortable, tell a trusted adult immediately.
- Never respond to any messages or send any messages that are mean, threatening, or make anyone feel uncomfortable. Go tell a trusted adult immediately.
- Follow the rules established by your parents for computer, phone and internet usage.
- Never download or install software/app or do anything that could jeopardize a family's privacy. If it happens by accident, go tell a trusted adult immediately.
- Other than your parents, do not share your internet password with anyone and change it regularly.

Discussion – Identify and maintain appropriate internet boundaries

List examples such as giving personal information to someone you only know online, clicking on a questionable site etc. Discuss how one would know if there is a violation of boundaries. Leader, make sure the following points are covered. The goal is to start to develop an internal sense of conscience about appropriate Social Media boundaries. Some suggested points to review:

- If you feel unsure or unsafe, you are probably not "safe" in what you are doing.
- You are not safe if someone tells you to keep your communication with them a secret.
- It is important that you are comfortable with a trusted adult seeing what you are writing/doing on the computer/tablet/gaming system or cell phone.
- Could you say face to face what you wrote about the person on the internet?
- Sending messages that intentionally harm or embarrass another person is not respecting their *Circle of Grace* and is considered cyberbullying.
- Sometimes we are tempted to lie on the internet; doing so may increase our tendency to lie in real life and is disrespectful of our *Circle of Grace*.
- Your *Circle of Grace* boundaries should not be crossed when you use the internet. This is to keep you safe and respect others' *Circle of Grace*.

PART 2

Activity-1 (Required) Social Media Smart Activity Sheet

- 1. Hand out two "How Social Media Smart are You?" Activity Sheets to the children (end of the lesson.)
- 2. Have the children complete one in class and be ready to discuss. Tell them this worksheet will not be collected. The second worksheet must be attached to the parent letter and completed with their parents and returned with the parent's signature.

- 3. The leader reviews each scenerio from the Activity Sheet with the class and ask, the following questions:
 - How hard was it to know how you would act in each scenerio?
 - Do you think some of the scenerios seem to make you choose between your friends and doing the right thing?
 - Can you give me some other difficult situations?
 - How does your *Circle of Grace* help in making the right decision?

Activity-2- (Optional) Discerning Media: Truth, Opinion or Fiction?

Now we are going to talk about how all forms of media and mass communication influence us in our *Circle of Grace*. We may never have considered media as violating our *Circle of Grace*. It can when it has negative words, images, or content that never should be in our *Circle of Grace*. It is important to be able to discern that media does not necessarily relay information or images in a truthful, accurate or respectful manner. Many times, especially in advertising or news it is meant to sway us to feel or act in a certain way. Discuss the below four points:

- Media, like cell phones and social sites/apps gives us ways to communicate with many people. Have children come up with other types of media forms and list them on the board (some other examples music, TV, movies, videos, computer games, books, advertisements, magazines, newspapers, radio, websites, blogs, etc.). Be sure to include the internet, websites, and magazines on the list.
- 2. Typical functions of media are to educate, communicate, inform, entertain, and advertise. List these five functions on the board. Go back over the types of media listed on the board and have children name what function(s) each type of medium performs.
- 3. *Have children break into small groups. Distribute pens, paper and sample news articles, advertisements, websites etc. Have groups answer the questions below with each sample:*
 - *A)* Is it true, an opinion or fiction?
 - B) What other information do you need to discern the content?
 - *C*) Does the content support our Catholic faith? Give your reasons.
 - D) Does the content go against our Catholic Faith? Give your reasons.
- 4. Gather children together as a large group. Have each group report on their answers.

Review

- 1. Media can provide the truth, an opinion, or fiction. God gave us the freedom to choose our own actions. How do we use and discern the media in a way that helps us make good choices? *Desired answers: choose media sources that support the Ten Commandments, the teachings of our Catholic faith, our parents, and trusted adults.*
- 2. What is the purpose of the messages that parents and trusted adults give us? What is the purpose of the influence our Catholic faith has on our lives *Desired answers: to teach, protect, love.* What is the purpose of the messages that are conveyed by the media? *Desired answers: to inform, sell things, influence your decisions, manipulate your opinions.*

- 3. What can we do if we are not sure if a type of medium is a positive or a negative influence? *Desired answer: We can always turn to a trusted adult to help us know if a type of medium is a good influence and to help us make decisions that keep us safe in our Circle of Grace.*
- 4. Ask the children to quietly reflect on all the ways that the media influence our thinking and behavior every day. Remind them that as people of faith, God has given us the Ten Commandments, the teachings of our Catholic faith, and our parents and trusted adults to help us make decisions and keep us safe in our Circle of Grace.

Action Plan

Review the following scenarios with the students and elicit what they might do in that situation before going over the action plan.

Scenario A: You are unsure or feel unsafe while viewing something or interacting with someone while using the computer or other technical device (ie: phone, tablet, gaming system etc) and you know your parents would not approve.

Action Plan

- **1.** Do not exit the site.
- 2. Find a trusted adult and show them what you are concerned about.
- 3. Review how you got to this point on the computer.
- 4. Have an adult help you exit the site.
- **Scenario B**: You are unsure or feel unsafe when you are asked by someone to view something on the computer/technical device (ie: phone, tablet, gaming system etc). It makes you uncomfortable and you know your parents would not approve.

Action Plan

- 1. Walk away from the computer.
- 2. Tell a trusted adult.

Distribute the parent information sheet and review again the listed guidelines. Have them write the action plan for each scenario on the information sheet.

Instruct the children to take the Parent Information Sheet home.

Leader calls class to prayer by asking children to quiet down. The leader does the Sign of the Cross modeling it for the children. Then say together,

Closing Prayer

Thank you, God, for always being with me in my Circle of Grace. Thank you for the gift of the Holy Spirit who helps me know what is good. Thank you for giving me people who care about me and want me to be safe. Amen

Opening Prayer

Holy Spirit, show us the way. Be with us in all we think, do, and say. Amen

Closing Prayer

Thank you, God, for always being with me in my Circle of Grace. Thank you for the gift of the Holy Spirit who helps me know what is good. Thank you for giving me people who care about me and want me to be safe. Amen

How Social Media Smart Are You? Activity Sheet

It is important to be *Smart* when you are online. Your parents and trusted adults can give you guidelines on how to use social media/technology safely. Remember if you are uncomfortable with what you are doing or viewing in your *Circle of Grace*, it is probably NOT safe.

Put "Y" for yes you agree, and "N" for no you don't agree or "U" for unsure next to the below statements. Your answer should reflect how you would respond to the situation. It is smart to be truthful. So, put "U" if you do not know what you would do or say. This way your parents/ trusted adults can help you figure out the best response for that situation.

- Your friend has been messaging someone she met on social media. She said her social media friend is 13 years old. Now this friend wants your friend to share her address. She does not know what to do since she has not told her parents about the messaging. You tell her the smart thing to do is not to tell her parents because then they will take her phone away. You tell her maybe she could meet this friend somewhere instead of giving out her address.
- You are on social media/internet/gaming and you see a "Pop Up" that has inappropriate images and words that make you uncomfortable. You leave the computer and go find your parent or trusted adult.
- You see one of the older kids at school taking photos of your classmates in the bathroom. You know no one is allowed to take pictures with a phone during school without permission. It makes you uncomfortable but you do not want the older kid to be mad at you so you do not tell anyone including your teacher or parents.
- You were sent several messages/texts saying hurtful things about one of your classmates. You notice that he has been out sick the last couple of days. You are worried about him so you talk to your parents or trusted adult about your concern.
- Your friend tells you that if you don't want your parents to see what you are doing on the computer, just minimize the screen when they enter the room. Although you are nervous about disagreeing with your friend, you tell him/her that you do not want to view images or seek information that would not be ok with your parents or trusted adults. Their trust in you is important.

Círcle of Grace Children's Rules and Guidelines for Social Media

Circle of Grace is a faith -based safety curriculum used by your arch/diocese. Today your child learned about how social media affects their Circle of Grace. Please review these rules and guidelines and activity sheet signed and returned to class.

Children's Rules and Guidelines for Social Media
