October Head Count Procedures and Documents - Repeated Notice

These statistics help to assess whether a parish is growing or diminishing in numbers; please make every effort to see that the headcount is carried out as accurately as possible. This information is useful not only for parish planning, but also for tracking growth and decline in the different geographical areas of the archdiocese. Additionally, it is a valuable tool for projecting the total population of the archdiocese, for providing information for statistical reports, and for distribution of material for the Advent and Lenten initiatives.

Please note that the headcount does not affect any other quota, e.g., *Catholic Standard* distribution or the Cardinal's Appeal.

Thank you for the care you have taken to assure the success of the October Headcount in previous years.

Notice Regarding Marriage Licenses in the District of Columbia

Please be advised that if there is a shutdown of the federal government on October 1, it could affect the issuance of marriage licenses in the District of Columbia.

The <u>DC Marriage Bureau office</u> that issues such licenses is within the DC court system, which operates under federal funding and will close if Congress is unable to reach a spending agreement.

In the past, however, the DC Council has given temporary authority to issue marriage licenses to the mayor's office, which is locally funded and thus would be unaffected by a federal shutdown. It is also possible that Congress will exempt the District courts from any disruption in federal funding. We will keep you apprised of the status of the issuance of licenses as events warrant.
