## Parish Incorporation Project Update

Thank you all for your cooperation and assistance that has allowed us to make excellent progress on this very important project.

## **Maryland Parishes**

All Maryland Articles of Incorporation have been filed with the state. We have received confirmation that many of the filed articles have been accepted and are waiting on additional confirmations, which we anticipate receiving soon.

We are currently working to retitle Maryland property in the name of the new parish corporations. Each Maryland pastor will be receiving a list of parish property via email. Please review the list of properties. Please continue to monitor your email as the Office of the General Counsel will be sending another email to schedule a virtual initial meeting for each pastor/administrator to attend in October for the new parish corporation, as required under Maryland law.

As you know, all DC parishes have been incorporated and at the first corporate meeting you were provided copies of your parish's Articles of Incorporation and adopted Bylaws. Service Agreements recognizing the relationship between the parishes and the CPA were also formalized. We are currently working to retitle parish property in the name of the new parish corporations.
