## Maryland Parishes Only - Energy Purchasing Cooperative Electricity and Natural Gas Contract Renewals

The Archdiocese of Washington has sponsored an energy cooperative since 2007 for parish, school, or related organizations located in Maryland and the District of Columbia. The cooperative enables our parishes, schools, and agencies to combine their buying power to purchase electricity and natural gas supply services at the best competitive price. We are assisted in the cooperative by our energy broker, CQI Associates.

The cooperative is offering a program for renewal members for Electricity and Natural Gas accounts located in Maryland for service beginning in **January 2024**.

It is now time to prepare for the upcoming contract renewal process.

### Montgomery County, MD Parishes Only - FY2024 Nonprofit Security Grants

Montgomery County has <u>announced</u> that it is appropriating \$900,000 to provide <u>Nonprofit</u> <u>Security Grants</u> to improve the security posture of nonprofit or religious organizations that are experiencing hate crimes or are at risk of becoming targets of hate crimes. Facilities (parishes/schools) can qualify for up to **\$20,000 each** for a 12-month period. Funds may be used for: current security personnel or to augment current security personnel; to pay for a security assessment or plan and associated expenses; to conduct security training, including contractor and training expenses; to develop and execute a security drill; and/or to purchase security cameras for the facility.

- *Applying*: Parishes/schools should submit the online application found <u>here</u>. Please keep in mind that information provided in the application is subject to public disclosure. **Applications will be accepted until November 10, 2023.**
- *Before accepting awards*. Parishes/schools will be notified of award decisions in December. If awarded funds, parishes/schools should send the final grant agreement to <a href="mailto:Legaladmin@adw.org">Legaladmin@adw.org</a> for final review before signing.

# Parish Electronic Banking Fraud Alert, October 2023

Several of our parishes experienced significant financial losses from electronic banking fraud made possible by gaps in the parish processes and controls. The following key controls must be utilized to safeguard the parish bank accounts.

• All on-line banking users authorized by the pastor must use multi-factor authentication *(MFA)*. MFA involves a user identifying themselves to the bank website using a code received by email or text in addition to using their username and password.

•*The parish must establish dual-approval for electronic disbursements.* A bookkeeper must not be able to initiate and complete electronic disbursements without the involvement of the pastor. Electronic disbursements include ACH payments, payroll direct deposit, account transfers, etc. The pastor must provide in-system approval of electronic transactions initiated by the bookkeeper.

•*The bookkeeper must independently verify requests to change the bank account to which ACH payments are made to employees or vendors.* For example, for a request received by email, the bookkeeper must telephone the requestor using a phone number from the parish records and confirm the identity of the requestor.
